- The Treasurer thanked the Webmaster for the new online payment system which has made paying Association dues easier and has also led to an increase in donations.

8. Matters arising

8.1 Teaching and learning coordinator

- 8.2 Inventory of classical artefacts
 - Samantha Masters (SU) presented feedback to the meeting on this project. Many artefacts from across South African museums, universities and other collections have been catalogued, with a description and photos of the item. These have been placed on a database, using NOTION.
 - The 1st goal of the project was to safeguard the objects by collecting information about them and collating the data. The 2nd goal is now to make this information accessible and sustainable.

- Members were asked to forward information on any collections that have not yet been catalogued.
- A request was made to link the database to the CASA website.
- The following suggestions were made from the floor:
- > Collaborate with the IT Departments of universities to help to achieve the 2nd goal.
- > A database could also be used to facilitate the sharing of teaching and learning materials compiled at different universities so that lecturers don't have to keep reinventing the same materials.
- > A person could be paid from CASA funds to create and maintain a database.
- > Proposals could be sent to CASA for funding, like paying to get students to help with the database.
- > A data coordinator could be made a member of the CASA executive. Philip Bosman proposed that someone be co-opted to the post by the CASA Executive. This was seconded by Jo-Marie Claassen.
- 8.3 Additional member for CASA social media
 - A proposal was put forward to have an additional member of the CASA Executive responsible for social media. Sonja Gammage proposed Natasha Ferreira. This was seconded by Philip Bosman. The member was accepted.
- 8.4 Vakindaba: relaunch, rebrand?
 - The chair suggested that the Vakindaba be relaunched in some way, with an online conference or by putting relevant papers on a website.
 - No firm decision was reached. The matter has been left to the new CASA executive in the hope that they would be able to find someone to host an Indaba in which ever form is feasible.
 - A suggestion was made to change the name of Vakindaba. Classics Indaba was suggested instead.

9. Acta Classica

- 9.1 Editor's report
 - The editor's report and the reviews editor's report were tabled for noting.
 - It was noted that printed copies of the latest volume of the journal would be out in the week following the meeting.
 - There was a request for a closer relationship between *Acta Classica* and CASA, such as the journal publishing conference proceedings. CASA members were encouraged to send papers from the current conference for consideration for publication in *Acta Classica*.

- This suggestion was rejected. It was reiterated that *Akroterion* is a Stellenbosch University publication and that CASA, although it appreciates being involved in the journal, has no executive privileges in it.

11. Ursula Vogel Memorial Bursary

The Executive is currently awaiting the Master of the Court to register the new board of Trustees. The matter is on hold until more information is forthcoming.

12. CASA Competitions
